Complete with special effects, Victorian carols, and Tiny Tim, *A Christmas Carol* is a must for the whole family.

This year's LTA production is led by stage managers **Melissa Dunlap** and **Sam Jensen**. Music direction is by **Linda Wells**, with choreography by **Michele Koros.** The set is designed by **John Downing** and will be built by **Julie Fischer**, painted by **Mona Wargo**, and decorated by **Eileen Doherty**.

Carol Clark will design props, and David Correia will provide sound design. The ghosts of past, present, and future will be lit by Nick
Friedlander and Michael Page. Veteran LTA costumers Jean Schlichting and Kit Sibley will provide gorgeous Victorian attire, and make-up and hair will be designed by Robin Worthington. Margaret Snow and Kirby Ruble will help the actors change characters a multitude of times as our wardrobe mistresses.

#### 'Tis the Season

It's hard to believe that the holidays are close at hand. As I write this, LTA's annual holiday tradition, *A Christmas Carol*, is deep into rehearsals. It is amazing to me – and heartening – that our production seems to gain luster every year. I vaguely recall when LTA closed its doors over the holidays. It's now hard to image a holiday in Alexandria without LTA's production! Each new director who undertakes *A Christmas Carol* at LTA interprets Charles Dickens' classic story in a slightly different way. Sometimes it is dark, and the ghosts are genuinely scary, and sometimes it's campy, with Scrooge being almost comical. Sometimes London is gritty, while sometimes it's filled with Victorian holiday cheer. All performances, however, remind us that we can break through the negativity of everyday life (political London in Victorian times had striking similarities to the Washington, D.C., of today) and find simple happiness and joy with our neighbors. If you haven't taken in LTA's *A Christmas Carol* lately or have never seen it, please do. 'Tis the season to rediscover the joy of the most exciting and meaningful time of the year.

The end of the year also means it is time for LTA's annual fundraising campaign. Over the next weeks, we will be sending out our annual appeal for donations. In the last year, we have undertaken a HUGE project to improve our building and increase the safety of our patrons. A few weeks ago, the Alexandria Fire Marshal completed his inspection of our new fire safety system. It is actually a cluster of different systems that include new hand-pull alarms, a laser beam detection system in the auditorium, sensors in the HVAC, smoke detectors, and a security company to monitor everything. It was an expensive but necessary purchase. Such purchases are possible only because our generous patrons remember LTA at the end of the year. We provide high-quality theater – in part, because we have the luxury of owning our building – but with that ownership comes expenses, and our annual donation drive is important for keeping our building in tip-top shape.

On behalf of the LTA Governors, I wish you a safe and joyful holiday season.

#### A Busy Time for LTA's Board

The Board of Governors continues to identify ways to make LTA's future shine bright.

The Board recently approved two new projects. The first will complete the re-wiring of our lighting system, which will enable productions to take advantage of new LED-based technology. LED lights run cool, last longer, and (ultimately)

cost the theatre less. The Board thanks Lights Co-Chairs Kimberly Crago and Jeff Auerbach for their efforts in making this happen. Second, the Board approved the installation of a small HVAC unit for the paint/lighting room, the only area in our building not covered by HVAC. Anyone who has volunteered to paint a set in the winter or summer can tell you that this backstage space is either freezing cold or scorching hot. Thank you to Governor for Building Frank Shutts and Building Chair Mary Hutzler for doing the legwork on this important project.

On the horizon: the Board will join forces with the LTA Council to look at the possibility of co-funding an update to the women's public restroom. Such a project on a room that gets a lot of use is overdue, and the Board thanks the Council for its leadership on the project.

The Board voted to approve Mary Beth Smith-Toomey and Elissa Hudson (co-producers), Colin Taylor (musical director), and Stefan Sittig (choreographer) to work with Kristina Friedgen (director) on The Producers opening in July 2019. We are delighted and honored to welcome this talented group back.

The Board again looks forward to LTA's representation in the Scottish Walk. Governor for Development Sarah Holt will coordinate LTA's efforts this year and will be looking for volunteers soon. The Scottish Walk is on December 1st. Looking a bit farther into the future, LTA will again be a venue in Alexandria's First Night on December 31st, and a call for volunteers will go out soon.

Finally, the Board decided to work with Business Manager Tina McCrea and Box Office Manager Crissy Wilke to streamline their responsibilities and allow them to work more collaboratively on larger projects. The Board is also looking for one or two business office volunteers to work a few hours each week. Work would vary based on the interests and skills of the volunteers. # *Governor's Message* Seasonal Planning

A good season is all about balance: a balance of experience on the committee and a balance of plays in our final slate. There needs to be something for everyone to maintain the vibrant and varied community at LTA. Farces, murder mysteries, dramas, and musicals large and small all have their place on the LTA stage.

We have just wrapped the selection of LTA's 2019/2020 season. I could not be prouder of the work that my play reading committee put in. If you see Lynn O'Connell, Sarah Holt, Franklin Coleman, Rich Amada, Brendan Quinn, Eileen Doherty, Joann Sordellini, Katie Beth Hicks, or Zell Murphy around the theatre, please thank them for the hours they spent winnowing down all the plays that came in through our annual open call, and who persevered through two rounds of selection. Our 2019 summer musical will be *The Producers*, followed by *A Few Good Men*, a Director's Choice open slot, and *A Christmas Carol*. 2020 kicks off with *A Gentleman's Guide to Love & Murder*, then *Moonlight and Magnolias*, *Bluestockings*, and wraps up with a classic comedy that we can't announce yet (expect to see the title in early January!).

We are now segueing into director selection. The 2018/2019 season received a record 43 applications, and I am hopeful that we will meet if not exceed that number of applications for the 2019/2020 season. Under the leadership of our Director Selection Chair Lynn O'Connell, committee members Brendan Quinn, Franklin Coleman, Charlie Dragonette, Nick Friedlander, Alan Wray, Rachel Alberts, Susan Devine, and Zell Murphy will be hard at work over the next several months.

I've had the privilege to hold the Governor for Seasonal Planning position for a little over a year now, and I am so happy to see that the participation from our theatre community continues to increase with each season. From the responses to open committee calls to the number of people who submit show suggestions to our open calls every year, so many voices are involved in seasonal planning. LTA's play reading and director selection committees represent our diversity: subscribers of all ages, new and experienced actors, directors, and tech representatives have all created another wonderful season.
