PRESIDENT

Eleanore Tapscott

It has been a privilege to serve on the LTA Board as Governor, Seasonal Planning, particularly as we celebrate LTA's 90th anniversary. I want to serve as LTA president



because I think my appreciation of LTA's past coupled with the ability to be forward-thinking is needed to ensure LTA's continued growth. I believe I am qualified for this position because:

I am a member of good standing with a track record of good performances as an actor and good productions as a director and producer.

I have collaborated with other governors and committees to:

- Introduce a staged reading series to acquaint LTA audiences with new plays and to provide new directors with production opportunities.
- Implemented other alternative programming for theatre such as cabarets.

During my tenue as governor of seasonal planning, LTA experienced an increase in the participation of underrepresented communities onstage and backstage and continued to receive community recognition for the quality of our productions – recently garnering 46 WATCH nominations across all categories.

As LTA looks to the future, I believe I have the interpersonal skills, effective management ability coupled with an extensive knowledge of theatre that will maintain LTA's high-quality standards and mission while providing a pathway to growth.

Eons ago, when I was in middle school and in my English class, we studied Romeo and Juliet by acting out the parts. I was, as they say, bitten by the bug, and have been a proud theatre nerd ever since. My passion for theatre led me to pursue a BA in Theatre from the University of California, Berkeley.

After college, I moved to NYC to continue my acting studies in a two-year conservatory program at the National Shakespeare Conservatory. After completing that program, I was fortunate to work as a professional actor, touring across the country with a classical theatre company for several seasons, playing a variety of Shakespearean roles. When not touring, I worked at various off-off-Broadway theatres, including a long stint at the Westside Repertory Theatre as a company member, board member, and finally as Producing Artistic Director, where I was responsible for producing a six-play subscription season. From 2021 to 2024, I served as the executive director for the Actors' Center.

This theatrical background, along with my experience in nonprofit program management (aka the various 401K survival jobs), was useful in my two terms on the LTA board as Governor, Seasonal Planning and will be beneficial as President.

In my nonprofit program management work, I learned to not only effectively manage committees but also work across multiple departments to ensure projects and programs are launched on schedule. As theatre artists, we sometimes base decision-making on feeling or instinct. The manager in me believes in data-informed decisions. These are challenging times facing the arts — but I believe adhering to our vision, learning about and involving our communities, and having actionable plans will help to ensure the next 90 years for LTA.

During my working life my spouse and I were season ticket holders at LTA for a number of years. I first experienced behind-the-scenes theatre work through my daughter, Deanna who was active in the theatre program at Bishop Ireton where she was on the painting and set building crew and also did lights, sound and stage management. At Ireton I first met some of LTA's notable people, our current President, Frank Shutts and esteemed costumer's Jean Schlichting and Kit Sibley.

After retirement and after a long period (years) of care giving for my spouse who had early on-set dementia, a bit more than three seasons ago I returned to LTA with a goal of working behind-the-scenes first experienced through my daughter at Ireton. I began ushering at LTA and as luck would have it while ushering one evening I ran into Kathy Murphy an old sailing friend and her friend Luana Bossolo. Through them I had my first of many experiences with set painting. It escapes me what that first production was but what I do know is that there seemed to be a siren's song coming from stage left and it wasn't long before as Shah Choudhury put it "You are breaking the union rules!" as I drifted back and forth between shops, painting on stage right and building on stage left, often during the same production. I believe I am one of a very few who go from shop-to-shop begging, "Please sir, I want some more!"

Since that first experience with painting, I have worked on numerous sets both building and painting including in no particular order, two or three Christmas Carols, Freaky Friday, Nacirema Society, Mary Stewart, Something Rotten, Two on the Aisle Three in a Van, Much Ado About Nothing, Matilda, Murder on the Orient Express and Jekyll & Hyde. For those last two, Kathy Murphy and I were co-lead painters, and we had the great honor of accepting the WATCH awards on behalf of all who painted with us on those sets.

When tech week is over and the curtain opens, I turn to Front of House where I have been ushering for more than three seasons and house managing for more than two seasons for two to three performances of every production that has been on stage at LTA.
